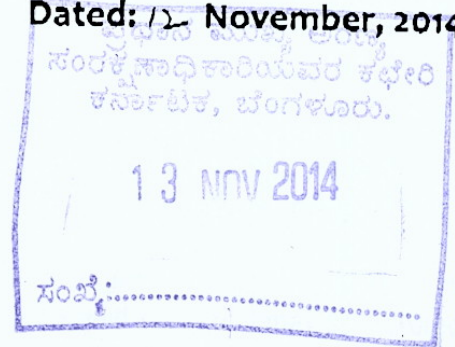

You are requested to take the following action immediately at your end:-

1. The complete bio-data of the candidates such as name, date of birth, scale of pay, date of appointment to the post, educational qualification of the directly recruited Forest Ranger by the Commission may kindly be sent to the **Uttarakhand Forest Training Academy, Haldwani, Rampur Road, Distt. Nainital (Uttarakhand)**, with a copy of the same to this office, well in advance for verification and record.

2. It may kindly be ensured that the candidates to be deputed fulfill the eligibility criteria as per Section II (Rule 4-11) of the Entrance & Training Rules (Revised) 2004 of the Government of India for Forest Range Officers. The **Director, Uttarakhand Forest Training Academy, Haldwani, Rampur Road, Distt. Nainital (Uttarakhand)** has the right to refuse admission to any of the candidate(s) who do not fulfill the eligibility and/or sponsorship criteria as per above rules. Abstract of the rules is enclosed herewith for ready reference.
3. The following training expenses of the candidates, deputed for training, may kindly be deposited with the **Director, Uttarakhand Forest Training Academy, Haldwani, Rampur Road, Distt. Nainital (Uttarakhand)**, in advance, as per rules:-

4. In case the sponsored candidates are to be treated as in-service, arrangements may kindly be made for timely payment of their pay and allowances. If the candidates are to be paid stipend, it may be ensured that minimum stipend of ₹ 20,000/- per month is paid to them.
5. An amount of ₹ 6000/- each is to be deposited in the Academy at the time of admission by the candidates towards Caution Money, which shall be refunded at the time of passing out.
6. A copy of the merit list prepared by the State Public Service Commission may also be sent to the **Director, Uttarakhand Forest Training Academy, Haldwani, Rampur Road, Distt. Nainital (Uttarakhand)**, and to this office for record.
7. It may be ensured that the trainees join at the **Uttarakhand Forest Training Academy, Haldwani, Rampur Road, Distt. Nainital (Uttarakhand)**, positively a day before the commencement of the course i.e. on 04th January, 2015 positively along with all original certificates, appointment order etc. failing which allotment of seat is liable to be cancelled.
8. In case, if it is not found possible to utilize the seats allotted, intimation, thereof, may be sent to the undersigned, immediately, so that seat/seats could be allotted to other needy States.
9. The seats allotted will not be transferable in any case.
